Just over **nine out of ten people (91%)** told us that they had been able to re-establish credit after bankruptcy.

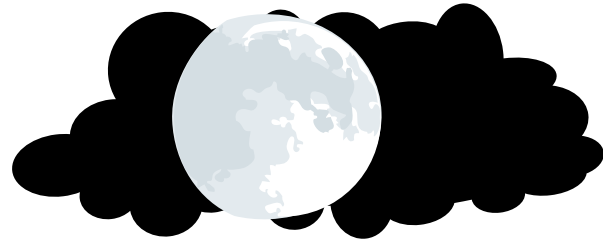

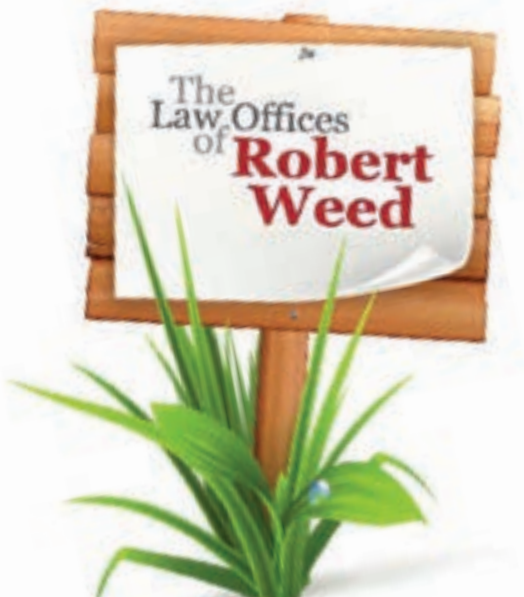
